MINUTES OF GENERAL MEETING, MOUNTAINEERING CLUB OF ALASKA April 16, 1975, 8:00 PM, Old Pioneer School House, Anchorage, Alaska.

The meeting was called to order by President FRITZ RIEGER. The Treasurer's report shows a balance in the checking account of \$649.64, and in the savings account of \$382.83.

The Executive Board agreed that MCA should join the Federation of Western Outdoor Clubs for a fee of \$30.00. The Club would have access to a lobbiest by joining.

NED LEWIS is the new climbing chairman. Five of the six climbs scheduled in the last month have gone off as scheduled. SHAWN OXFORD is the new equipment chairman. His telephone number is 279-3283.

TOM MEACHAM, Conservation Committee chairman, gave a report on the Hatcher Pass recreation area proposal. DONA AGOSTI, Hiking Committee coordinator, says we have many hikes scheduled, but the response has been limited. The Katmai information sheet is ready. ROD WILSON, co-chairman of Geographical Names Committee, gave a report on the renaming of the Ruth Amphitheater as the Don Sheldon Amphitheater. The Huts Committee still needs a coordinator. The committee has a trip planned to Mint Glacier Hut and to Eklutna Hut to survey their condition.

TERRY McWILLIAMS, coordinator of the Climbing Schools, reported that two kinds of schools will be offered. One is an Introduction to Backpacking and the other is a basic Climbing School.

BILL BARNES, JR., last year's president, was awarded an ice axe in appreciation of his service.

MCA has been asked to participate in the Clean-Up for Hope, May 10. TERRY MCWILLIAMS will act as coordinator.

TOM MEACHAM moved that we extend an honorary membership to PAUL CREWS. The motion was seconded and passed unanimously.

PRESIDENT'S PEN

MCA programs during the past month were a mixture of grand successes and lesser frustrations. The Matanuska Glacier practice ran like clockwork thanks to the efforts of the ARG. The backpacking class was enthusiastically received and the final preparations for the climbing school are under way. Our thanks to the instructors who are generously donating their time and talents to these activities.

The late spring and heavy soggy snow have thwarted a number of MCA trips in recent weeks. Last minute cancellations or changes in destination became commonplace in April and point out the need for better communications within the Club. The upcoming nice weather will evaporate our excuses for cancellations anyway!

Noble efforts were made by the Huts Committee. PAUL CREWS donated two weekends, his airplane and considerable skill as a glacier pilot in an attempt to reconnoitre the Eklutna-Whiteout cabins. Turbulence prevented a landing on the glacier, but we gained an appreciation of the logistics involved in reaching the cabins. NED LEWIS led a reconnaissance ski tour in the direction of the Mint Glacier cabin, but was diverted to Snowbird Mine by poor skiing in the Little Susitna Valley.

We would like to encourage all members to participate in the climbs scheduled for the summer. Many trips have a choice of routes which offer both technical challenges for

those who seek them and straightforward approaches for the rest of us. Hikers are welcome and can stop at the appropriate places. The designation "experience climb" on the schedule simply means that the trip is suggested for recent graduates of the climbing school. All MCAer's are welcome. We still need leaders for some of these climbs. Please be generous and offer to lead at least one trip this summer.

We receive about two "urgent" calls a week from the Alaska Center for the Environment asking for MCA input at hearings, etc., particularly concerning disposition of public lands having some climbing interest. Finally, let's plan an MCA Barbecue in June. Our backyard is fine. We need suggestions, ideas for games, etc.

BITS AND PIECES

PAUL JANKE, BRUCE HILLIARD, JIM RENKERT, and NED LEWIS, along with two dogs from a homestead hear Eklutna Lake, climbed West Twin on May 10. Gusty winds and showers accompanied the climbers along the route of rotten snow and rocks. No skis were used. Four hours to the summit, arriving at 1 PM. Two hours to descend.

DURHANE and FRITZ RIEGER ambled through the alder above Rainbow Valley on the way to Helga's Mountain on May 10. Lots of wind and the first mosquitoes of the season

A party-organization meeting was held for prospective climbing school instructors at the Rieger's on May 7. So enthusiastic and engrossing was the conversation that much beer (but no food) remained after all went home. The beer will be donated to the June MCA Barbecue.

ARG - Glacier Rescue Practice

Held as scheduled - more or less - at the end of April. The only injury occurred before the classroom session on April 24 when GIL TODD, organizer of the practice, attempted to vault a fence in his backyard and broke a bone in his foot. NORM STADEM conducted the session at the Turnagain School Gym where ropes were set up for prussick practice. Sunday, April 27, BARRY KIRCHER, MIKE RICHARDSON, and JIM HOLLOWAY led a class of nine students in a practice session on Matanuska Glacier including self rescue, pulley systems, and self arrest. (Note: the cost is now \$3.50 per car to use the road to the Glacier.)

FIRST WINTER ASCENT OF MOUNT FORAKER (17,400°)

On March 14, 1975, Steve and Gary Tandy made the first winter ascent of Mt. Foraker, Mt. McKinley's western companion in the Alaska Range. This acheivement marks the second-highest winter climb in Alaska, trailing only the climb of McKinley itself in 1967.

A party consisting of the Tandy brothers and five other Anchorage climbers, Don and Dave Pahlke, Larry Tedrick, 3rian Miskil, and Gaylan McCord flew to the mountain on February 13 and attempted a direct southern ridge route. Poor ice conditions on the steep ridge, combined with a 180-foot fall by Tedrick (which fortunately resulted in no more than a fractured rib) caused the party to retreat to base camp on the 24th day.

All of the climbers flew out with the exception of the Tandy brothers who remained to make an Alpine-style assault by the Southeast Ridge route, carrying all of their supplies at once, without using relays. On their summit day, the two brothers made a marathon climb from their camp at 13,200 feet to the 17,400-foot summit and returned.

CONSERVATION COMMENTS

A bill to create a Hatcher Pass Recreation Area and a Talkeetna Mountains Park is working its way through the legislature in Juneau. The Talkeetna Mountains Park would be much larger than the Hatcher Pass State Park proposal which failed in Juneau last year. The proposed Recreation Area is now drawn so as to eliminate the active mining area which caused the defeat of the previous bill.

The Talkeetna Park portion of the bill looks especially promising to mountaineers, since the proposed park area is larger than Chugach State Park. Interested MCA ers should write or wire their Anchorage-area or Palmer-area legislators very soon. Do it today:

The Cook Inlet Native Corporation has proposed to amend the Native Claims Settlement Act to permit it to select its land entitlement from the Anchorage area and the Swanson River-Swan Lake area on the Kenai. The areas of most interst to Anchorage which the Corporation wants to own are Campbell Airstrip (the Bicentennial Park, or portions of it), Point Campbell Military Reservation, and Point Woronzof.

Have you used these areas for public recreation and open-space enjoyment? Do you want to in the future? Our Congressional Delegation in Washington (Senators Gravel and Stevens, and Rep. Young) would like to receive your comments on these proposed land transfers. The time is short because several bills amending the Native Claims Act are going before Congressional Committees this week.
